Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 8.05 crore bank facilities of Krishna Polynet (KP) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Krishna Polynet (KP) based at Gujarat was established in 2003 as a partnership firm. The firm is engaged in manufacture and supply of Packing Net Bags and PVC Cling Films. The products offered find their wide use in various packaging applications as well as in farms for protecting crops from insects. The manufacturing facility is located at Dhoraji (Gujarat) with an installed capacity of 60 tons per month for Packing Net bags and 30 tons per month for PVC Cling Films. The Partners, Mr. Gopal Hirapara, Mr. Bipin Rakholiya, Mr. Atul Domadiya and Mr. Manoj Hirapara are in same line of business since 2003.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit

quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.
