Rating Rationale

Acuité has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 15.50 Cr bank facilities of Gemus Engineering Limited (GEL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Gemus Engineering Limited (GEL) was established in 1996 and started operating since 2001. The company is engaged in manufacturing of customized ductile iron products with the installed capacity of 7000 MTPA per annum. The company is based in Kolkata (West Bengal) and is currently managed by Mr. Shyam Bihari Sharma, Mr. Om Prakash Choudhary and Mr. Mahesh Chowdhury.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
