Acuité has reviewed the long term rating of '**ACUITE BB+** (read as **ACUITE double B plus**) on the Rs. 15.00 crore bank facilities of Ku-Koo-Ch-Ku Poultry Farm (KPF). This rating is and is based on best available information.

KPF, setup in 1988, is engaged in the poultry business and sells broiler birds. The firm has its farms and feed unit in Raigad district (Maharashtra). The day to day operations of the firm is managed by Mr. Dilip Pathre and his son Mr. Kunal Pathre.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
