Rating Rationale

Acuité has withdrawn the long term rating of '**ACUITE B+** (read as ACUITE B plus) and the short term rating of '**ACUITE A4**' (read as ACUITE A four) on the Rs.6.85 Cr. bank facilities of Accura Weldrods Kovai Private Limited (AWPL). The rating continues to be flagged as an 'Issuer Not-Cooperating' based on best available information.

The rating is being withdrawn on account of the request received from the company and the charges mentioned in the MCA portal as per Acuité's policy on withdrawal of ratings.

About the Entity

Established in 2011, Accura Weldrods Kovai Private Limited (AWPL) is a private limited company based out of Coimbatore, Tamil Nadu engaged in manufacturing of welding electrodes. The firm is promoted by Mr Nanthagopal.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
