Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plusf)rom 'ACUITE BB-' (read as ACUITE double B minus) to the Rs.11.50 crore bank facilities of Mahaluxmi Processing House Private Limited (MPH). The rating continues to be flagged as "Issuer Not Co-operating" and the downgrade is based on information risk.

About the Company

Mahaluxmi Processing House Private Limited (MPHPL) was incorporated in the year 2008 by Mr. Bharat Bhushan Dawar and Mr. Suman Dawar. The company is engaged in the yarn dyeing business and it started its commercial production on October, 2012. The company has its manufacturing unit at Ludhiana with an installed capacity of 15 tonnes per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
