Rating Rationale

Acuité has downgraded its long-term rating of Bhagwan Precision to '**ACUITE BB+**' (read as **ACUITE double B plus**) from '**ACUITE BBB-**' (read as **ACUITE triple B minus**). This rating is now an indicative rating and is downgraded on account of information risk.

Bhagwan Precision (BP) is a partnership firm established in 2010. The firm is based at Kaliyar village in Haridwar, Uttarakhand. The firm is engaged in the manufacturing of auto parts and components for Hero Motocorp.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
