Acuité has reviewed long-term rating of 'ACUITE BB' (read as ACUITE double B) and short-term rating of 'ACUITE A4+' (read as ACUITE A four plus) to the Rs. 10.32 crore bank facilities of ADINATH INDUSTRIES (AI). This rating is now an indicative rating and is based on best available information.

Parasnath Enterprises (PE), established in 1997, is a Delhi-based partnership firm. Mr. Ashok Kumar Jain, the key partner, has around three decades of experience in the rubber and plastic business. The firm is engaged into manufacturing of rubber component for automobile industry.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.
