Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE BB+**' (read as **ACUITE double B plus**) and short term rating of **ACUITE A4+** (read as **ACUITE A Four plus**) to the Rs.9.00 crore bank facilities of General Auto Electric Corporation. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Mumbai based, General Auto Electric Corporation (GAEC) was established in 1959 as a partnership firm by Mr. Ramesh Gandhi and Mr. Gopal Gandhi and now the operations are managed by Hetal R. Gandhi (Partner) and Nehal G. Gandhi (Partner) having over three decades of experience in the electronic components industry. The firm is engaged in the manufacturing of Railway Products and Industrial Products for the Indian Railways and also providing after sales services for the products of Siemens, being its channel partner.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
