Rating Rationale

Acuité has reaffirmed the long term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and short term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.30.00 Cr. bank facilities of Maharashtra Polybutenes Limited (MPL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

The Maharashtra based Maharashtra Polybutenes Limited is a non-government public company incorporated in September 1988. It is involved in the manufacturing and marketing of polybutenes and polyisobutenes. The company turned a sick unit in 2006, and was taken over by Mr. Brijmohan Rathi, the Chairman and Managing Director.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity.
