Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs.6.60 Cr. bank facilities of Kothari Wheels on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Kothari Wheels (KW) is a partnership firm established in 2001 by Mr.Rupesh Kothari. The entity is located in Pune, Maharashtra. KW is an authorised dealer of Honda Motorcycle & Scooter India Private Limited (HMSI) vehicles and is engaged in the sale of new vehicles, servicing of vehicles, sale of spare parts and accessories. The firm has 3S facility (3S stands for Sales, Service and Spares).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
