Acuité has reviewed the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 6.50 crore bank facilities of Patel Filters Infrastructure(PFI). This rating is now an indicative rating and is based on best available information.

Patel Filters Infrastructure (PFI) was established on 18th July 2006 by Mr. Rameshbhai S. Patel, Mr. Akshay R. Patel, Ms. Bhaktiben R. Patel and Ms. Manisha A. Patel. All the partners are active in the business. PFI, is a Gujarat based firm, engaged as contractor for designing, construction, erection, installation and commissioning of water and waste Treatment Plants. PFI is primarily into manufacturing of water treatment plant for purification of drinking water.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
