Rating Rationale

Acuité has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) and short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 6.50 crore bank facilities of Patel Filters Infrastructure. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

Patel Filters Infrastructure was established in 2006 by Mr. Rameshbhai S. Patel, Mr. Akshay R. Patel, Ms. Bhaktiben R. Patel and Ms. Manisha A. Patel. All the partners are active in the business. Patel Filters Infrastructure, is a Gujarat based firm, engaged as contractor for designing, construction, erection, installation and commissioning of water and waste Treatment Plants. Patel Filters Infrastructure is primarily into manufacturing of water treatment plant for purification of drinking water.
