Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as '**ACUITE B plus**') and the short term rating of '**ACUITE A4**' (read as '**ACUITE A four**') on the Rs.13.20 crore bank facilities of SPR Buildtech Limited (SPRL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SPRL, incorporated in January, 2016, is a real estate construction company promoted by Mr. Sanjeev Saluja and Mr. Sudesh Gupta. The company is in the process of development of a seven-tower residential complex at Faridabad (Haryana).

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
