The firm is engaged in manufacturing of HDPE pipes and implement rural water supply schemes on Turnkey basis. The firm has an installed capacity of 1,000 tonnes of HDPE pipes per annum. The firm is primarily catering to the rural water supply needs by executing tender based contracts for Telenagana, Andhra Pradesh and Kerala government.
