**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and short-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 12.50 crore bank facilities of Balaji Engineering. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

The Tamil Nadu-based, Balaji Engineering was established in 2013 is a partnership firm engaged in the manufacturing of stoneware pipes at Vriddhachalam. BE procures raw materials from local vendors in Tamil Nadu and Karnataka. The firm caters to construction companies in Tamil Nadu, Karnataka and Andhra Pradesh. The day-to-day operations are led by Mr. Ramanathan. The annual production capacity stands at 18,000 MT.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
