

Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short-term rating of ACUITE D (read as ACUITE D) on the Rs. 12.55 Cr bank facilities of United Engineering Industries Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Madhya Pradesh based United Engineering Industries Private Limited was incorporated in 2011 and is engaged in the heavy steel fabrication business. The company undertakes designing of heat exchangers, steel bridge girders among others for Indian railways and several power sector companies. It also offers installation and maintenance services and end-to-end solutions. The installed capacity is 12000 tonnes per annum. Currently John Vincent John and Neil John are the directors of the company.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity / industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
