Rating Rationale

Acuite has reviewed long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) to the Rs.6.68 crore bank facilities of Kalimata Vyapaar Private Limited (KVPL). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

About the Rated Entity:

Incorporated in 2006 by Mr. Anant Jhavar and Mr. Vikash Jhavar, KVPL is engaged in the manufacturing of components such as elastic rail clips and coil springs, used mainly by the Indian Railways and wagon manufacturers. KVPL is an approved vendor for Research Design and Standards Organization (RDSO) under Ministry of Railways in Lucknow. The manufacturing unit is located at Barjora (West Bengal).

For FY2017 (Provisional), KVPL reported Profit after Tax (PAT) of Rs.0.21 crore on total operating income of Rs.19.95 crore compared to PAT of Rs.0.20 crore on total operating income of Rs.25.24 crore in FY2016.
