Acuite has withdrawn the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.6.00 Crore bank facilities of Anila Seed Processing Industries (ASPI). The rating withdrawal is in accordance with Acuite's policy on withdrawal of rating.

The rating is being withdrawn on account of request received from the company and NOC received from the banker.

ASPI, established in 2003, is a Hyderabad-based firm promoted by Mr. M. Vidyanath Reddy, proprietor. The firm is engaged in the processing and packaging of agricultural seeds.

**Non-cooperation by the issuer/borrower:** Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
