Acuité has reviewed the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs.5.43 crore bank facilities of Corus Decor Private Limited (CDPL). This rating is now an indicative rating and is based on best available information.

Corus Decor Private Limited (CDPL), incorporated in 2010, is an Ahmedabad-based company engaged in the manufacture of paper-based decorative laminate sheets at Sanand, Gujarat.

For FY2014-15, the company reported profit after tax (PAT) of Rs. (0.09) crore on operating income of Rs.0.87 crore, compared with net profit of Rs.0.04 crore on operating income of Rs.7.27 crore in FY2013-14. The net worth stood at Rs.3.62 crore as on 31 March, 2015 compared with Rs. 3.71 crore a year earlier.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
