Acuité has reviewed the long-term rating of '**ACUITE D** (read as ACUITE D)' on the Rs. 30.00 crore bank facilities of TARAPUR TRANSFORMERS LIMITED. This rating is now an indicative rating and is based on best available information.

Tarapur Transformers Limited, incorporated in 1988, is a Thane-based company engaged in the manufacturing, repairing and refurbishing of power transformers. The company has two manufacturing units located at Boisar (near Mumbai) and Vadodara (Gujarat) with combined manufacturing capacity of 1,839.40 MVA.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.
