Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE BB-' (read as ACUITE double B Minus) from 'ACUITE BB' (read as ACUITE double B) and reaffirmed the short-term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 10.00 crore bank facilities of Kox Med & Labs Pvt Ltd. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Delhi based - Kox Med & Labs Private Limited (KMLPL) established in 2001 is engaged in the distribution of nonsurgical cardiology products such as ducts, stents, pace makers, among others. The company caters to hospitals in Delhi/NCR. The company at present managed by Kapil Suri and Davindra Kumar Suri.

Non-cooperation by the issuer/borrower:
