Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 16.74 crore bank facilities of Brahampuri Steels Limited (BSL). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

Brahampuri Steels Limited (BSL), incorporated in 1994, is a Jaipur-based company engaged in the manufacture of mild steel (MS) bars, angles, sections, flats and fixtures. The company has two manufacturing units at Jaipur, Rajasthan, with a combined installed capacity of 12,000 mtpa. Directors of Brahampuri Steels Limited are Hemant Gupta, Dinesh Kumar Gupta, Divyarth Gupta, Mahendra Kumar Gupta, Surendra Kumar Gupta.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
