Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.12.00 Crore bank facilities of Sri Bhavani Saw Mills (SBSM). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

SBSM, a partnership firm promoted by Mr. Dilip Patel and Mr. Praveen Patel is engaged in the trading of timber. The firm has a sawing facility in Thirunelveli District (Tamil Nadu), in close proximity to the Tuticorin port and it is established in the year 1984.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
