Acuité has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.25.00 crore bank facilities of Malhotra Electronics Private Limited (MEPL). This rating is now an indicative rating and is based on best available information.

MEPL, incorporated in 1986, is a Noida based company promoted by Mr. Ravinder Singh Malhotra. The company is engaged in the manufacturing of electronic goods such as LED televisions apart from cabinets and CTV chassis and has an installed capacity of 650000 metric tons per annum.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
