Acuité has downgraded the long term rating to '**ACUITE B+** (**read as ACUITE B plus**)' from '**ACUITE BB-**' (**read as ACUITE double B minus**) on the Rs. 5.50 crore bank facilities of Kushal Karyashala (KK). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Kushal Karyashala (KK), a New Delhi based partnership firm was established by Mr. Vijay Mangla, Mr. Ankur Mangla and Mr. Ankit Mangla in 2002. The firm manufactures brooms, wipers, ropes, floor duster, hanger and laundry clips.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
