# The issuer dia not co-operate; based on best available information.

### Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 17.00 crore bank facilities of Parshvanath Overseas (PO) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Parshvanath Overseas (PO), established in 2009, is a Nagpur-based proprietorship firm promoted by Mr. Jayesh Choudhary. The firm imports in-shell almonds and cashew nuts and other agro products and sells the same to group entities and in the domestic market for processing.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
