Rating Rationale

Acuité has reaffirmed and withdrawn the long-term rating to 'ACUITE B' (read as ACUITE B) on Rs.0.50 crore bank facilities of Steel World Company and withdrawn the proposed long-term facilities of Rs. 4.50 crore without assigning any rating of Steel World Company. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

The rating has been withdrawn as per Acuite's policy of withdrawal of ratings as applicable to the respective instrument/facility. The rating has been withdrawn on account of the request received from the company and the NOC(No Objection Certificate) received from the banker.

About the Company

Steel World Company, established in 2010, is a Pune-based partnership firm owned by Mr. Mohammad Nayeem Choudhary and Mr. Abdul Wahid Choudhary. SWC trades in metal scrap.

About the Group

Steel India Company (SIC), established in 2006, is a Pune based proprietorship firm owned by Mr. Mohammed Nayeem Choudhary. The firm trades in metal scrap and took over the existing business of Bombay Steel (established in 1983). The latter was engaged in the trading of iron and steel scrap.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non co-operation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
