SMERA has suspended the long term rating of '**SMERA BB**' (read as **SMERA double B**) assigned to the above mentioned facilities of Micrologic Integrated Systems Private Limited (MISPL). The suspension follows SMERA's inability to undertake rating surveillance in the absence of requisite information of the company.

About the Company

MISPL, established in 1986, is a Bangalore-based company promoted by Mr. M. S. Jairam and Mr. S. G. Nagesh. The company provides industrial computing, testing and system integration solutions to several industries.

For FY2013-14, MISPL reported profit after tax (PAT) of Rs.0.83 crore on total income of Rs.11.12 crore, as compared with PAT of Rs.0.30 crore on total income of Rs.7.62 crore in FY2012-13. The net worth stood at Rs.2.52 crore as on March 31, 2014, as against Rs.0.33 crore a year earlier.
