Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 5.51 crore bank facilities of R K Industries (RKI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Rating Rationale

About the Company

R K Industries (RKI) was established in 2012 as a partnership firm by Mr. Shashi Kiran, Mr. Linga Reddy and Mr. Thodupurnoori Reddy. It is engaged in processing of parboiled rice with an installed capacity of 5 tons per hour (TPH). The administrative office and processing facility is located at Renikunta Village in Karimnagar district of Telangana.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
