Acuite has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as '**ACUITE A four plus**') on the Rs. 8.00 crore bank facilities of Jb Plastochem Private Limited. This rating is now an indicative rating and is based on best available information.

JBPPL, incorporated in 2011, is a Maharashtra-based company promoted by Mr. Avinash Kantilal Jain, Mr. Kailash Hari Khairnar and Mrs. Heena Avinash Jain. The company is engaged in the manufacturing and trading of PVC stabilisers, wood pallets, boxes and crates among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
