Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 5.20 crore bank facilities of Jai Hanuman Education Society (JHES). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Established on 02 September, 2008, Jai Hanuman Education Society (JHES) is engaged in providing education from pre-nursery to standard VIII . JHES is headed by Mr. Anup Singh (Founder), Mr. Vinod Singh (President), Mrs. Anita Devi (Vice President), Mr. Anil Singh (Secretary), Mr. Mukesh Rani (Treasurer), Mr. Udesb (Member) and Mr. Sudesh (Member). JHES has its head office at Sonipat (Haryana).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
