#### **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B Plus) and the short-term rating of 'ACUITE A4' (read as ACUITE A Four) on the Rs. 5.54 Cr bank facilities of iLife Medical Devices Private Limited (IMPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

iLife Medical Devices Private Limited IMPL, incorporated in 2007, is a New Delhi based commenced commercial production of Intravenous (IV) cannula and threeway stop cock from August 2009. IMPL is engaged in manufacturing of medical disposables like intravenous (IV) cannula and three way stop cock under the brand name "one plus" and "one flon" The company is headed by Mr. Tushar Anand, Mr. Pradeep Anand and Mr. Kartik Palta. The Directors are ably supported by a team of professionals.

#### Non-cooperation by the issuer/borrower:
