SMERA has long-term rating of '**SMERA BB-**' (read as **SMERA BB minus**) and short term rating of '**SMERA A4+**' (read as '**SMERA A four plus**') on the Rs. 9.10 crore bank facilities of Vinayak Cars Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

About the Rated Entity

Vinayak Cars Private Limited (VCPL) incorporated in 2007 is a Bengaluru-based authorised dealer for Skoda Auto India Private Limited. The company has also taken dealership of Yamaha Motors and DSK Benelli for two wheelers. VCPL has two showrooms and two service stations for Skoda and a showroom and service station each for Yamaha and DSK Benelli in Bengaluru. The company also has a stockyard (with stacking capacity of 152 cars) in K. R. Puram Bengaluru.

For FY2014-15 VCPL reported net profit of Rs.0.59 cr on operating income of Rs.93.82 cr as compared with net profit of Rs. 0.52 cr on operating income of Rs. 86.42 crore in the previous year.
