SMERA has suspended the above mentioned rating of Shemrock Organics Private Limited (SOPL). The suspension follows SMERA's inability to undertake rating surveillance in the absence of requisite information from the company.

### About the Company

SOPL, incorporated in 2007, is a Chandigarh-based company promoted by Mr. G. S. Chawla. SOPL undertakes production and trading of chlorinated paraffin wax and hydrochloric acid used in manufacturing of footwear and cables.

For FY2013-14, SOPL reported profit after tax (PAT) of Rs.0.50 crore on operating income of Rs.21.94 crore, as compared with PAT of Rs.0.40 crore on operating income of Rs.17.24 crore in FY2012-13. The net worth stood at Rs.4.79 crore as on March 31, 2014, as compared with Rs.2.45 crore a year earlier.
