**The issuer did not co-operate; based on best available information.

Acuité has reviewed the short term rating of '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs. 8.19 crore bank facilities of Shiv Electricals (SE). This rating continues to be an indicative rating and is based on the best available information.

Shiv Electricals (shiv), incorporated in 1992, is a Noida based partnership by Mr. Raj Kumar, Mr. Pankaj Goel and Mr. Uma Shankar Panday. The firm engaged in the business of installation, setting-up of power substation, laying transmission lines and supply of electrical equipments to government authorities and local municipal corporations.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
