Rating Rationale

Acuité has downgraded the short-term rating to '**ACUITE A4**' (read as **ACUITE A4**) from '**ACUITE A4+**' (read as **ACUITE A Four plus**) on the Rs. 8.19 crore bank facilities of Shiv Electricals (SE). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Shiv Electricals (SE), incorporated in 1992, is a Noida based partnership by Mr. Raj Kumar, Mr. Pankaj Goel and Mrs. Uma Shankar Panday. The firm engaged in the business of installation, setting-up of power substation, laying transmission lines and supply of electrical equipments to government authorities and local municipal corporations.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
