Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE BB- (read as ACUITE double B minus)**' from '**ACUITE BB' (read as ACUITE double B)**' on the Rs. 10.00 crore bank facilities of Manishankar Oils Private Limited (MOPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Manishankar Oils Private Limited (MOPL) was incorporated in the year 1998 by Mr. Manoj Murarka in Chomu, Rajasthan. Manishankar Oils Private Limited is engaged in manufacturing of edible oils such as Castor oil, Sunflower oil, Soyabean oil, Groundnut oil etc.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
