Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 5.00 crore bank facilities of Vishwakarma Engineering Works on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Vishwakarma Engineering Works (VE Work) was established in Mumbai by Mr. Arvind Patel, the proprietor, in the year 1986. The firm is engaged in the business of metal fabrication.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
