Acuite has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.8.00 crore bank facilities of Paviter Metals Private Limited (PMPL). This rating is now an indicative rating and is based on best available information.

PMPL, incorporated in 2008, is a Ludhiana-based company promoted by Mr. Naresh Dhawan and family. The company is engaged in the trading of steel angles, channels and rounds.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
