Rating Rationale

Acuité has downgraded the long term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 11.64 Cr. bank facilities of Chemin Control and Instrumentation Private Limited (CCIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Chemin Controls Instrumentation Private Limited (CCIPL) was incorporated in 2004, it is a Puducherry based company, established to take over the running businesses of Chemin Consulting Engineers (established in 1981), Chemin Controls, Peruson & Chemin (established in 1987), and Chemin Institute of Instrumentation Management (established in 1999). It is engaged in undertaking turnkey instrumentation and electrical projects. The company provides services for the erection and commissioning of control systems as well as designing and manufacturing of electrification control panels as per the customer specifications. The company is promoted by Mr. P. Rangaraj, has more than four decades of experience in the similar business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
