SMERA has reviewed the long term rating of '**SMERA BB**' (read as **SMERA double B**) on the Rs.20.00 crore bank facilities of Aggarwal Hospital & Research Services Private Limited (Aggarwal Hospital). The ratings are now indicative ratings and are based on best available information.

Non-cooperation by the issuer/borrower: SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity: Aggarwal Hospital & Research Services Private Limited (Aggarwal Hospital) was incorporated in 1990 by Dr. Ajit Gupta who is also a founder of Park Group of Hospitals. At present the operations are managed by Dr. Ajit Gupta and Dr. Ankit Gupta. Aggarwal Hospital provides healthcare services.

For FY2014-15, the hospital reported loss of Rs.0.12 cr on operating income of Rs.20.71 cr as compared with loss of Rs.0.150 cr on operating income of Rs.1.90 cr for FY2013-14. The net worth stood at Rs.10.83 cr as on March 31, 2015 as compared with Rs.7.56 cr a year earlier.
