#### Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BB-**' (**read as ACUITE Double B Minus**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs.13.79 crore bank facilities of Shakthi Murugan Textiles (SMT). This rating is now an indicative rating and is based on best available information.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

SMT, established in 1999, is a Coimbatore-based partnership firm promoted by Mr. R. Murugesan, Mr. Velumani Shanmugan, Ms. Shanti Subramaniam and Mr. M. Naveen. SMT is engaged in manufacturing of cotton yarn and weaving of grey fabrics. The firm is also engaged in generating wind power which used for both captive consumption and sale to TNEB. The day-to-day operations of the firm are managed by Mr. R. Murugesan and Mr. M. Naveen, partners of the firm.
