Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) to the Rs.76.00 crore bank facilities of ASM Industries India Private Limited (AIPL). he rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

ASM Industries India Private Limited (AIPL) was originally established as a partnership firm in 1981 by Mr. Madhusudan Kejriwal and other partners as Anand Silk Mills. In 2010, the constitution was changed to a private limited company and the name was changed to AIPL. The company is engaged in the manufacturing of fabric (shirting & suiting) and readymade garments. The company has 4 manufacturing facilities is located in Umbergaon, Gujarat.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit ratings is based.
