APPL, incorporated in 2002, is a Delhi based company promoted by Mr. Sameer Anand and Ms. Payal Anand. The company trades in furnace oil.

For FY 2014-15, APPL reported losses of Rs.0.50 crore on operating income of Rs.34.13 crore, as compared with losses of Rs.0.05 crore on operating income of Rs.43.26 crore for FY2013-14. The company's net worth stood at Rs.5.22 crore as on March 31, 2015, as compared with Rs.5.75 crore a year earlier.
