**The issuer did not co-operate; based on best available information.

Acuité has reviewed the long-term rating of '**ACUITE B-**' (**read as ACUITE B minus**) on the Rs. 22.00 Cr. bank facilities of Alliance Petroleums Private Limited (APPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

APPL was incorporated on 11 February, 2002 by Mr. Sameer Anand and is located at Pitampura, New Delhi. APPL is engaged in the business of trading of furnace oil. APPL's supplying furnace is mainly in the north-western region in India. APPL is a distributor of M/s Essar Oil Limited and distributing Furnace Oil.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
