**Rating Rationale**

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) on the Rs. 22.00 Cr. bank facilities of Alliance Petroleum Private Limited (APPL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

**About the Company**

Alliance Petroleum Private Limited (APPL) was incorporated on 11 February, 2002 by Mr. Sameer Anand and is located at Pitampura, New Delhi. APPL is engaged in the business of trading of furnace oil. APPL’s supplying furnace is mainly in the northwestern region in India. APPL is a distributor of M/s Essar Oil Limited and distributing Furnace Oil.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
