Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 262.00 Crore bank facilities of SRI KRISHNA STOCKISTS & TRADERS PRIVATE LIMITED. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Incorporated in 2009, SRI KRISHNA STOCKISTS & TRADERS PRIVATE LIMITED is an Andhra Pradesh based company. Currently, the company is promoted by Mr. Thota Kanna Rao. The company is engaged in trading and processing of maize and neem seed.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
