Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 8.00 crore bank facilities of AMR Sumangalee Jewellers. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

AMR Sumangalee Jewellers (ASJ) was established in 2013 by Mr. P. Arumugam, Mr. P. Manivel, Mr. P. Ravikumar, Mr. A. Manojkumar and Mr. M. Ilanjeyan. ASJ is a retailer of Gold and silver Jewellery based in Salem, Tamil Nadu. The Partners have been in the business for more than 2 decades.

About the Group

The Sumangalee group was established in 1996 as a partnership firm. The group is based in Tamil Nadu. The firm is engaged in retailing of gold, silver and diamond jewellery. The group comprises Sumangalee Jewellers (established in 1996), established within the city premises of Salem and AMR Sumangalee Jewellers (established in July 2013 and operational since September 2013) and established on the outskirts of the city limits. The day-to-day operations of the group are managed by Mr. P. Arumugam, Mr. P. Manivel, Mr. P. Ravikumar and others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
