## **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.61 crore bank facilities of Parshva Food International (PFI) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Parshva Food International (PFI), a Nagpur-based proprietorship firm, was established in 2009 by Mrs. Manju Pravin Choudhary. The firm is engaged in the processing of cashew nuts and manufacturing of candied fruit cubes.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
