Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) and reaffirmed the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 7.25 crore bank facilities of Arrow Powertech Private Limited (APPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Arrow Powertech Private Limited was incorporated in 2010, is a Vadodara-based company promoted by Mr. Yogesh Thakkar. The company is engaged in the assembling and trading of power backup equipment sold under the ‘Arrow’ brand name. The company’s product profile includes inverters, biometric equipments, batteries and UPS (Uninterrupted power supply) in offline, online and line interactive categories.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
